## **Background**

 Acting for a foreign government body in relation to a tunneling dispute in Southern Africa under a FIDIC form of contract, involving claims of about US\$100m, including dealing with the appointment of an UNICTRAL arbitration panel and with issues relating to expert evidence and adverse ground conditions.

### **Energy Projects (Contentious and Non-Contentious)**
